Registration, Paperwork & Payment: All paperwork is located on our website (www.jloequineservices.com). Forms including liability releases are to be printed and filled out completely prior to your arrival to camp. Our registration is on first come first serve basis and our camps fill quickly with a limit of 10 students per week. Full payment is due at time of registration. Changing of weeks will not be allowed, no exceptions. Due to limited availability, we request that you cancel at least 14 days before your camp. This gives us the opportunity to fill the camp date. \$100 per child of your payment is non-refundable. If you do not cancel prior to the 14 days, you will forfeit the full payment for the camp. No refunds or make-up days can be offered for missed days.

### What to Bring and Wear

- Campers need to arrive READY TO RIDE. This means long pants and closed toed shoes.
   Helmets will be provided, but students are welcome to bring their own. Helmets must be HORSEBACK RIDING HELMETS ONLY.
- Shorts for after riding, a change of clothes
- Bagged lunch & snack, a re-fillable water bottle
- Carrots/sliced apples for the horses
- Sunscreen, bug spray, hats, sunglasses
- Cell phone policy: cell phones can be checked in at drop-off but students will not be allowed to use their phones throughout the day except in cases of emergency. We will not be responsible for stolen, lost, or broken phones.
- MEALS: Student provided bagged lunch- Monday thru Thursday. Fridays only is Pizza Day. We provide pizza, fruit, chips, and drinks.
